# **Meeting Minutes**

June 12, 2025

#### I. Call to order

Senator Travis Hackworth, Chairman, called to order a meeting of the Southwest Virginia Higher Education Center Board of Trustees Executive Committee at approximately 4:15 p.m. on Thursday, June 12, 2025.

#### II. Roll call

### III. Closed Session
